Section 4 - FIRST-AID MEASURES

Inhalation: If breathing is difficult, remove victim to fresh air and keep at rest in a position comfortable for breathing. Get medical advice/attention if you feel unwell.

Section 5 - FIRE-FIGHTING MEASURES

Suitable Extinguishing Media: Dry chemical or CO₂.

Unsuitable Extinguishing Media: None: Use extinguishing agent suitable for type of surrounding fire.

Special Protective Equipment and Precautions for Firefighters: Keep upwind of fire. Vapors may cause dizziness or asphyxiation without warning. Vapors from liquefied gas are initially heavier than air and spread along ground. Contact with gas or liquefied gas may cause burns, severe injury and/or frostbite. Fire may produce irritating, corrosive and/or toxic gases. Wear positive pressure self-contained breathing apparatus (SCBA). Wear chemical protective clothing that is specifically recommended by the manufacturer. It may provide little or no thermal protection. Section 6 - ACCIDENTAL RELEASE MEASURES

Methods and Materials for Containment and Cleaning Up: Do not touch or walk through spilled material. Stop leak if you can do it without risk. Do not direct water at spill or source of leak. Use water spray to reduce vapors or divert vapor cloud drift. Avoid allowing water runoff to contact spilled material. If possible, turn leaking containers so that gas escapes rather than liquid. Prevent entry into waterways, sewers, basements or confined areas. Allow substance to evaporate. Ventilate the area.

Environmental Precautions: Report spills as required by local and national regulations. Prevent entry into storm sewers and waterways.
