- No aplique este producto de modo que entre en contacto con trabajadores u otras personas, ya sea directamente o por arrastre. Solamente quienes lo manipulen y se encuentren protegidos pueden permanecer en el área durante la aplicación.
- No permanezca en la zona tratada. Salga inmediatamente y quédese fuera de la zona tratada hasta que los aerosoles, vapores y/o nieblas se hayan dispersado. Espere dos (2) horas después de la aplicación y después abra las ventanas, los respiraderos y las puertas por dos (2) horas más. Si se detecta algún olor, se requiere ventilación adicional.
- No lo utilice en las áreas donde haya alimentos en los establecimientos que manipulan alimentos, restaurantes u otras áreas donde se preparan o procesan alimentos comercialmente. Cualquier población de insectos puede contener individuos con resistencia natural al Nebulizador para chinches de cama y pulgas Hot Shot y a otros insecticidas del Grupo 7C. Los individuos resistentes podrían dominar la población de insectos si este grupo de insecticidas se usa repetidamente en los mismos campos. Se deben seguir estrategias de manejo de resistencia adecuadas.

Para retrasar la resistencia al insecticida, considere:

- Evitar el uso consecutivo del Nebulizador para chinches de cama y pulgas Hot Shot o de otros insecticidas del Grupo 7C que tengan un sitio objetivo similar en la misma especie de insectos.
- Basar el uso del insecticida en un programa IPM integral.
- Monitorear la población de insectos tratada para detectar la pérdida de eficacia en el campo.
- Comunicarse con el especialista de su extensión local, asesores de cultivos certificados y/o el fabricante para el manejo de la resistencia al insecticida y/o recomendaciones de IPM para el problema de insectos no viables resistentes y el lugar específico.

### Cómo usar este producto correctamente

Con una lata de nebulizador se puede tratar una habitación de hasta 16 pies x 16 pies con techo de 8 pies de altura, o 2,000 pies cúbicos de espacio abierto. NO use más de un nebulizador por habitación. NO lo use en espacios pequeños y cerrados, como closets, gabinetes, ni debajo de cubiertas de cocina ni mesas. NO lo use en habitaciones cuyo tamaño sea de 5 pies x 5 pies o menor. En cambio, permita que la niebla entre desde otras habitaciones.

Para un control más eficaz de los insectos nocivos de almacenamiento y las cucarachas, abra todas las puertas y cajones de las alacenas para que penetre mejor la niebla. Retire todos los alimentos infestados y tírelos a la basura en el exterior.

Para el control de pulgas y garrapatas, limpie completamente con la aspiradora todas las alfombras y muebles tapizados, a lo largo de los bordes inferiores, debajo de los muebles y dentro de los closets. Coloque la bolsa de la aspiradora en una bolsa de basura y tírela en la basura en el exterior. Limpie con un trapeador todas las superficies de suelo firme.

### ANTES DE APLICAR LA NIEBLA

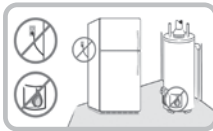

Apague TODAS las fuentes de ignición como llamas piloto (cierra las

válvulas del gas), otras fuentes de fuego y aparatos eléctricos en funcionamiento que tengan ciclo de encendido y apagado (como por ejemplo, refrigeradores, termostatos, etc.). Llame a su empresa de servicio de gas o compañía administradora si necesita ayuda con las llamas piloto. Cubra los pisos de madera y los muebles de madera que se encuentren en la zona cercana al nebulizador con papel de periódico o una tela protectora. Abra los gabinetes, alacenas, gavetas, closets y puertas en las zonas a tratar. Coloque una silla, mesa pequeña o plataforma en el centro de la habitación que se va a tratar y cubra con papel de periódico. Para mejores resultados, trate todas las áreas infestadas.

Complete y coloque la etiqueta colgante en la puerta de la zona tratada para avisar a la familia y otras personas con acceso a la zona tratada que no entren durante dos (2) horas.



### PARA COMENZAR A APLICAR LA NIEBLA

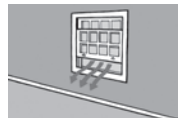
