

## DIRECTIONS FOR USE

### REPELLENCY - REPELS MOSQUITOES AND TICKS FOR UP TO 8 HOURS

Hold container 6 to 8 inches from skin and spray with a slow, sweeping motion evenly over exposed skin. Do not apply over cuts, wounds, freshly shaven or irritated skin. Do not allow children to handle this product, and do not apply to children's hands. When using on children, apply to your own hands and then put it on the child. After returning indoors, wash your child's treated skin and clothes with soap and water or bathe. **TO APPLY TO FACE:** Spray palm of hand and rub on. **FOR CONTINUED PROTECTION:** Reapply about every 8 hours or sooner if effectiveness is diminished; not to exceed 3 applications per day.
