<b>Suitable Extinguishing Media:</b>	Dry chemical or CO <sub>2</sub> .
<b>Unsuitable Extinguishing Media:</b>	None: Use extinguishing agent suitable for type of surrounding fire.
<b>Special Protective Equipment and Precautions for Firefighters:</b>	Keep upwind of fire. Vapors may cause dizziness or asphyxiation without warning. Vapors from liquefied gas are initially heavier than air and spread along ground. Contact with gas or liquefied gas may cause burns, severe injury and/or frostbite.
